<u>Up-to-Date Information</u>: I agree that I will keep the information relating to change of mobile numbers, change of addresses, contact persons up-to-date throughout the year. This is very important in case we need to contact you in an emergency.

<u>Photographs</u>: I agree that my children's photographs can be included in any school documentation, including brochures, displays, School Website, Twitter and newspaper articles. Photographs of children will include individual photographs and group photographs. We also make recordings of key events in the life of the school.

<u>Visits away from School</u>: I agree to my child leaving school premises to visit areas of interest in our immediate locality, eg museum, Church in order to enhance and extend pupils' learning experience. (If it is an official school trip for a whole day, separate documentation will be issued.)

Child Protection: I confirm that I have read the Child Protection Policy on the website.

<u>Intimate Care</u>: I confirm that I have read the Intimate Care Policy on the website. A change of clothes for the younger children must be provided in a plastic bag with their name clearly written.

I authorise staff to change my child if they have a toileting accident.

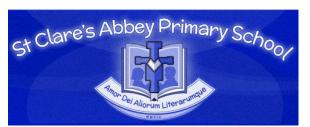
If your child soils him/herself, we will ask you to come to school to change them.

<u>Baptism Certificate</u>: I will forward a copy of my child's Baptism Certificate if my child was <u>not baptised</u> in the Newry Parish. This will be required for the Sacraments of First Confession, First Holy Communion and Confirmation. This can be e-mailed to <u>mmcneany269@c2kni.net</u>.

<u>School Uniform</u>: I confirm that I have read, understood and accepted school uniform requirements. Please refer to the School Website.

<u>Attendance</u>: I confirm that I have read and understood the Attendance Information notice on the website.

<u>GDPR</u>: I agree to my child's details being shared as per GDPR Guidelines. We need to share pupil details for reasons including Assistive Technology Programmes eg, Wellcomm, Mathletectics, Lexia, Bug Club, Nessy, Lexia, Accelerated Reader etc.

Within the current climate, PHA will need the names of those who have been in a bubble with another person who has tested positive for Covid 19 for Track and Trace purposes. They will use this information simply to alert you that this has been the case. There will be no meeting with PHA with parent or child.

<u>Medical Form:</u> I agree that I will request, complete and return to school a Medical Form for my child if he/she has any medical conditions. *It is a requirement to complete a Medical Form for <u>any medical</u> <u>condition</u> your child may have <u>without exception</u>.

<u>First Aid</u>: I agree that I will complete and e-mail a medication form pertaining to my child should one be required before leaving medication into school. There are two forms:
